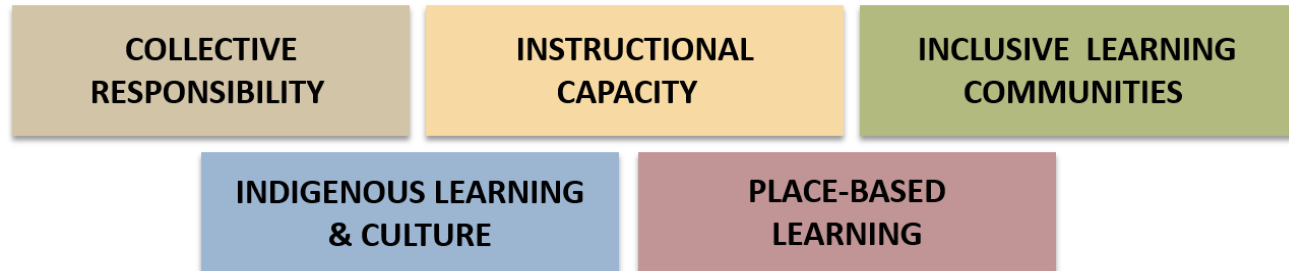

The Williams Lake First Nation (WLFN) Local Education Agreement (LEA) signing ceremony was held on February 26. Board of Education Chair Angie Delaine, superintendent, directors of Instruction, and principals and staff from all the schools where WLFN students attend were guests of the nation for a joyful celebration of our work together to enhance the success of students. Principals were presented with medicine pouches and feathers for their leadership and care with respect to the 101 WLFN students across public and private schools on T'exelc territory. Director Gustafson spoke on behalf of the district sharing many examples of positive initiatives and successes. The evening hosted by WLFN was an opportunity to look back at what has been accomplished and ahead to the work still to be done for gaps to be closed and all students thriving and meeting their goals.

BC Superintendent of Indigenous Education Dr. Brad Baker was an honoured guest and pointed to the local agreement as “lighthouse for other districts to follow.” Cariboo-Chilcotin School District is very proud of the collaboration and close working relationship with the WLFN education team that transforms an accountability document into systemic change for student success.

While in district at the invitation of Williams Lake First Nation, BC Superintendent of Indigenous Education Dr. Brad Baker visited Lake City Secondary. He got to see the resource centre with hundreds of learning kits available for schools to use to enhance learning about local Indigenous history and culture. He had the pleasure of engaging with students as they worked on anorak and regalia projects. He also met the district Indigenous Role Models Michaelaine Evans of T'exelc and Terrence Ramos of Esk'etemc who emceed and

spoke at the LEA ceremony. Dr. Baker commended both role models for their confidence and exemplary representation of the district as young leaders.

Dr. Baker joined a meeting of the [Indigenous student leadership council](#) that has started meeting regularly at Lake City Secondary. Students are invited to give input on educational decisions that impact their education. Students will continue to meet throughout the year, sharing their voices, and shaping their school experience. The district is looking to create a similar structure at Peter Skene Ogden Secondary. It was powerful for the students to have a provincial leader in Indigenous Education hear them.

Learning About Traditional Plant Medicines

Tea Blending

As part of the district-wide learning program supported by the Indigenous Education Council, all Grade 3 classes have the opportunity to learn about traditional medicine harvesting, blend healing medicines, and take home tea to share with family.

Tatla Lake school “was grateful to welcome Dancing Water Sandy to lead a tea blending workshop that introduced students to the traditional medicinal qualities of local plants. During the session, students learned about plants such as mullein, rose hips, Labrador leaf, and soapalalie berries and how they have been used traditionally to support health and wellness.

Students had the opportunity to create their own tea blends, including a cough and cold tea and a sleepy time tea. This hands-on learning experience helped students understand how knowledge of the land has long been used to care for people and support well-being.

We were also pleased to have students from Anahim Lake School join us for this shared learning opportunity. It was a wonderful day of connection, learning, and appreciation for Indigenous knowledge and the important role that plants play in traditional medicine.”

At Mile 108 Elementary “students in Ms. Fast’s class created two beautifully fragrant tea blends — Sleepy Tea and Cold & Cough. Students individually and thoughtfully created their own blend from a selection of Indigenous plants. Our special guests, Dancing Water and Freda Alphonse, generously shared their knowledge about the unique qualities and health benefits of each plant. Students learned how the plants are traditionally and respectfully harvested, and how they have been used to support wellness for generations. It was a wonderful opportunity for hands-on learning, cultural connection, and appreciation for the gifts of the land.”

Some of the most prominent concerns currently surrounding use of social media platforms, smartphones, and artificial intelligence will be discussed.

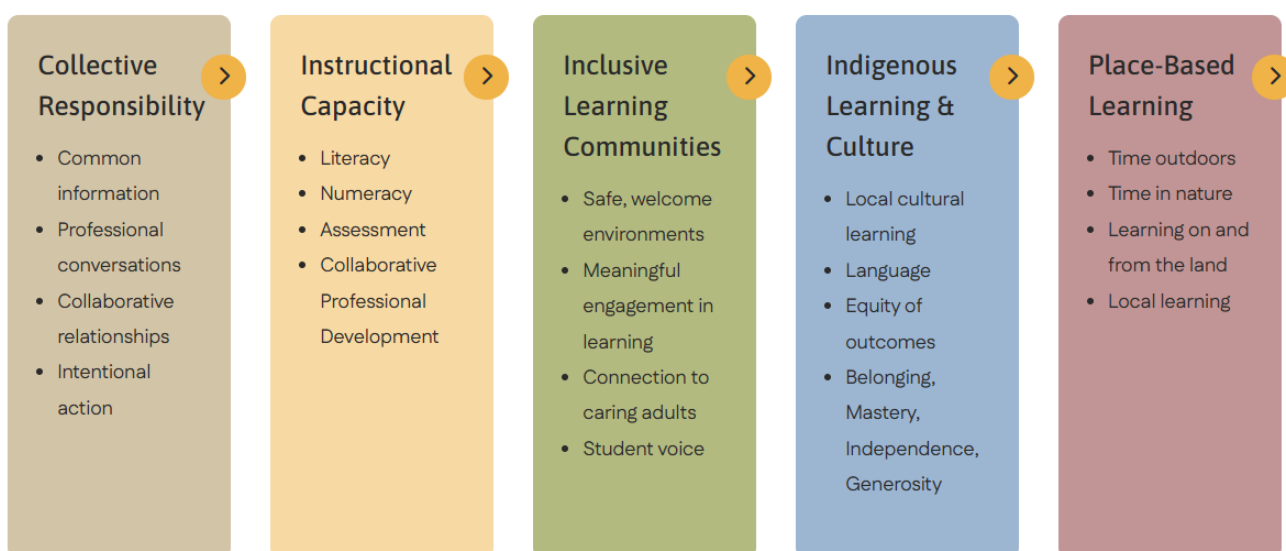

RE: Item #9.1 - 70-Mile School – TELUS Statutory Right of Way

BACKGROUND

TELUS Communications Inc. (TELUS) has requested that a Statutory Right of Way (SRW) be provided on the 70-Mile School site to accommodate their upgrade to a new, state-of-the-art fibre optic cable service. Currently, a BC Hydro SRW is registered on the land to accommodate an existing pole line. The poles are jointly owned by BC Hydro and TELUS; however, the current SRW only supports BC Hydro infrastructure.

TELUS is requesting a similar SRW to that provided to BC Hydro, which will formalize an agreement for their service. The pole line itself will not change as the requested agreement will apply to the current footprint, and no new poles or structures will be installed on the property.

First and Second reading of the Bylaw was approved by the Board at the February 23, 2026 Regular Meeting.

RECOMMENDATION

It is recommended that the Board approve thirds and final reading of the Bylaw at the March 09, 2026 Regular Meeting.

**THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 27 (Cariboo-Chilcton)
70-MILE SCHOOL TELUS STATUTORY RIGHT-OF-WAY – BYLAW 2026-1**

WHEREAS section 65 (5) of the School Act provides that a board of education may exercise a power with respect to the acquisition or disposal of property owned or administered by the board only by bylaw;

AND WHEREAS pursuant to Section 96 (1) of the School Act, “land” includes any interest in land, including any right, title or estate in it of any tenure;

AND WHEREAS:

- I. TELUS Communications Inc. (“TELUS”) propose to register a Statutory Right-of-Way on land owned by The Board of Education of School District No. 27 (Cariboo-Chilcotin) (“Board”) legally described as PID: 013-283-740 – Block A District Lot 1645 Lillooet District, on the 70-Mile School site (“Property”);
- II. TELUS proposes a Statutory Right-of-Way to the portion of land in the same location of the existing BC Hydro and Power Authority Statutory Right-of-Way (#124007E) as shown on the site plan attached hereto as Schedule, subject to the Standard Charge Term agreement;
- III. the Property is facility number 2727067;
- IV. the address of the Property is 2545 N Bonaparte Road, 70-Mile House, British Columbia, V0K 2K2, and the legal description of the Property is:

Parcel Identifier: 013-283-740 – Block A District Lot 1645 Lillooet;
- V. the Board is satisfied that the granting of the Statutory Right-of-Way to TELUS will not interfere with the Board’s use of the Property for educational purposes.

NOW THEREFORE be it resolved as a Bylaw of the Board that the Board grant the Statutory Right-of-Way to TELUS.

BE IT FURTHER resolved that the Secretary-Treasurer be and is hereby authorized, on behalf of the Board, to execute and deliver the Statutory Right-of-Way to TELUS in registrable form and on such terms as the Secretary-Treasurer may consider advisable, and all related and ancillary documents required to complete the granting of the Statutory Right-of-Way.

This bylaw may be cited as “70-Mile School TELUS Statutory Right of Way – Bylaw 2026-1”.

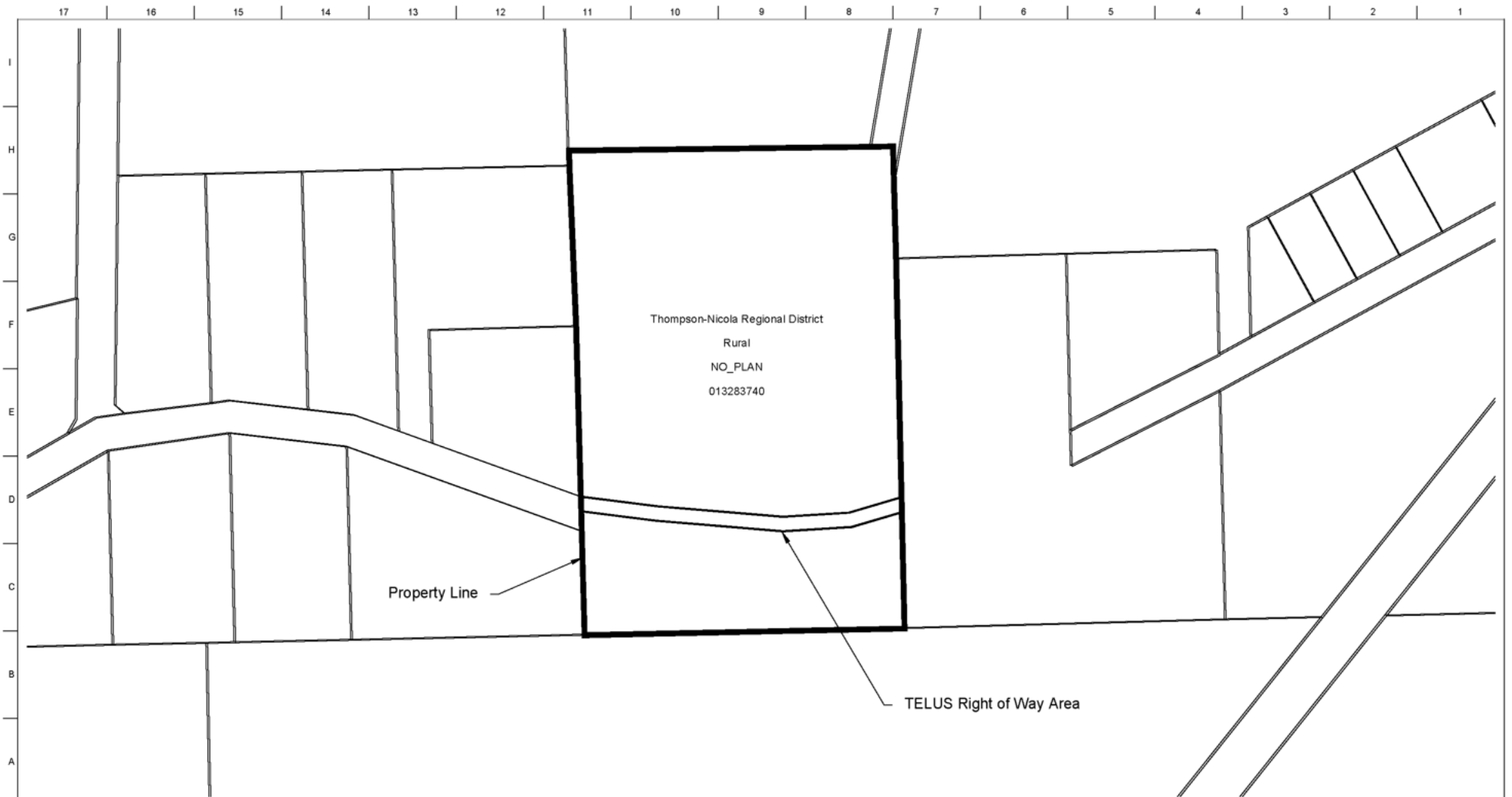
